Stretching as far as the pyramids on a clear day in January 2006, this view of Cairo is framed by a mashrabeya window at the Al-Azhar Park. Visible from the park is the dire living situation of much of Cairo, which is gradually improving due to social development programs that have worked to provide adequate housing and healthcare facilities for the grossly overpopulated city. The Aga Khan Trust for Culture created this lush 74-acre park in the center of Cairo as an urban renewal project. Cairo has one of the lowest ratios of green space to urban population in the world, roughly equivalent to one footprint per inhabitant. The Azhar Park Project has become a model of creative solutions for a spectrum of social, economic, and ecological problems that cities face today.
